REPORT ON THE VISIT TO GOVT. VETERINARY POLYCLINIC, KURNOOL

The Department of Zoology, St. Joseph's Degree College, Kurnool, organized an educational visit to the Govt. Veterinary Polyclinic, Kurnool, on 2nd August 2024. The visit was aimed at giving students practical exposure to veterinary healthcare practices, enhancing their understanding of animal health management, diagnostic techniques, and treatment protocols.

Objectives of the Visit

- 1. To familiarize students with the functioning of a veterinary polyclinic.
